Introduction

Escalate Arts is a new place-based partnership, including Surrey County Council, Spelthorne Borough Council, Ashford Youth Club and Artswork to develop a new 'Cultural Hub' in Staines-upon-Thames in Surrey.

The two-year project aims to bring together creative organisations, education and creative employers to create a step change in how young people design, engage with, work in and enjoy culture in Spelthorne.

The project partners wish to appoint an independent evaluator to work with us to design and construct a robust evaluation framework, to understand our lasting impact on cultural engagement for direct beneficiaries and the wider Spelthorne community.

This learning will be used to replicate strategies of youth-led cultural programming across the county, regionally and nationally, to enhance learnings & opportunities.

Outcomes

Our 2-year success measures are mapped against our 4 strategic goals:

Programme Delivery

Project activity will be delivered across 5 programme strands, each of which is developed by their own steering group with representation from key partners, including:

Staines Youth Collective	A group of young people aged 11 – 15 and 16 - 24. The Youth Collective are
	supported to develop their own skills and programme cultural events in Staines Library

Staines Library Programme	A 24-month programme of events and activities is delivered. Signposting for cultural engagement initiatives is developed
Community Programme	A programme of events and activities is delivered in wider areas of Spelthorne, including a fund for local artist commissions
Schools Programme	A programme of events and teacher training is delivered in Spelthorne Schools, and a teachers' network is developed
Creative Skills	Working with partner organisations, we develop new 'creative pathways' across Surrey, to support young people gaining further skills. This includes (but is not limited to) accreditation, such as digital badging, work experience, apprenticeships etc. Surrey is a leading destination for creative professionals and enterprises. Surrey has more than 10,000 digital startups, film and TV studios, artistic producers, and entertainment companies employing 45,000 people. Home to, Shepperton Studios, CoSTAR National Lab.

Background

The project uses the opportunity provided by the new Staines-upon-Thames flagship library to establish a 'cultural hub' addressing gaps identified in SCC Community 2030 Vision, Health & Wellbeing Strategy, Surrey Skills Plan, SCC Libraries & Cultural Strategy & Spelthorne Leisure Strategy.

Spelthorne is currently a priority location, and the most deprived borough in Surrey with the highest level of child poverty. Our research has shown only 46% engage with culture locally & 69% would take part in more cultural activity if available.

The project will be delivered in collaboration with a number of local partners, including:

- 5 Youth clubs (Ashford, Shepperton, Leacroft, Sunbury & Stanwell) their Youth Directors & CYP
- Arts Council National Portfolio Organisations incl. Artswork who have extensive experience designing & delivering youth leadership training
- Surrey Creative Cluster University for the Creative Arts (UCA), Shepperton Studios & Netflix
- Arts Partnership Surrey council partnership, incl. SCC & Spelthorne BC
- Surrey CC Youth Services, Libraries, Surrey Arts (Local Cultural Education Partnership Culture Box Surrey & Surrey Music Hub)
- Local schools and colleges, University of Surrey, UCA, and Royal Holloway, University of London
- Community groups, including 2 food banks to reach the most disadvantaged

Deliverables

The evaluator will be responsible for delivering:

- Evaluation Framework: A comprehensive evaluation framework, that includes a
 theory of change and sets out clear methods, tools, and timelines for data
 collection and analysis, to be used across all programme strands.
- 2. **Methodology**: A range of creative, participatory methods combining both qualitative and quantitative techniques to provide a comprehensive understanding of the programme's impact. Data will be particularly collected either directly or indirectly from young people. These methods should be accessible, engaging, and capable of being delivered by local partners and youth participants, as well as the project team. Methods might include:
 - Collecting case studies from diverse participants, including young people, creative organisations, educators, and employers
 - Surveys, focus groups, and interviews with young people, partners, and stakeholders.
 - Creative methods such as digital storytelling or participatory arts activities to engage young people in reflective practices.
 - Analysis of data in relation to outcomes and the theory of change
- 3. **Support for Partners**: Tools, templates, and training to help delivery partners collect data directly from young people, ensuring that their feedback informs both current and future activities.

- 4. **Mid-point Review**: A review report conducted at the programme's mid-point, identifying progress, challenges, and recommendations for adjustments.
- 5. **Final Evaluation**: A comprehensive final evaluation report for Arts Council England, including key findings, case studies, and recommendations for sustaining and scaling the programme in future phases.

Responsibilities

The evaluator will be expected to:

- attend events and activities, to support with data gathering.
- attend project meetings, on teams and in person
- Work with partners to collaborate

A budget of £28,000 inclusive of VAT and expenses, is available for this work

The successful appointee will be able to demonstrate the following:

- The skills and experience to design an appropriate and effective evaluation methodology that includes robust indicators of impact and effective data collection processes, both quantitative and qualitative.
- Knowledge of cultural learning in the UK
- Organisational and partnership development expertise, specifically in collaborative models of governance and leadership
- The ability to pull together diverse sources of data into a coherent whole
- Analytical skills to determine robust indicators of impact
- Report writing skills
- Strong interpersonal and organisational skills to engage effectively with stakeholders across the region
- Administrative and project management skills
- Availability to deliver the research in line with the required timescale
